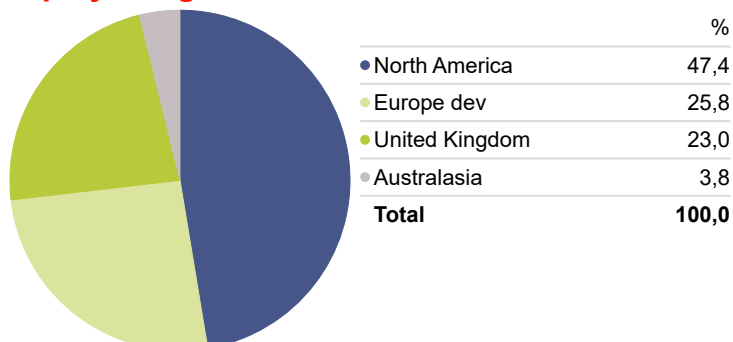

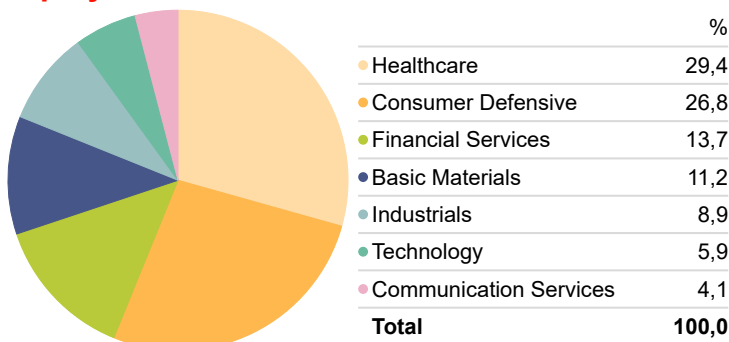
Investment Growth
