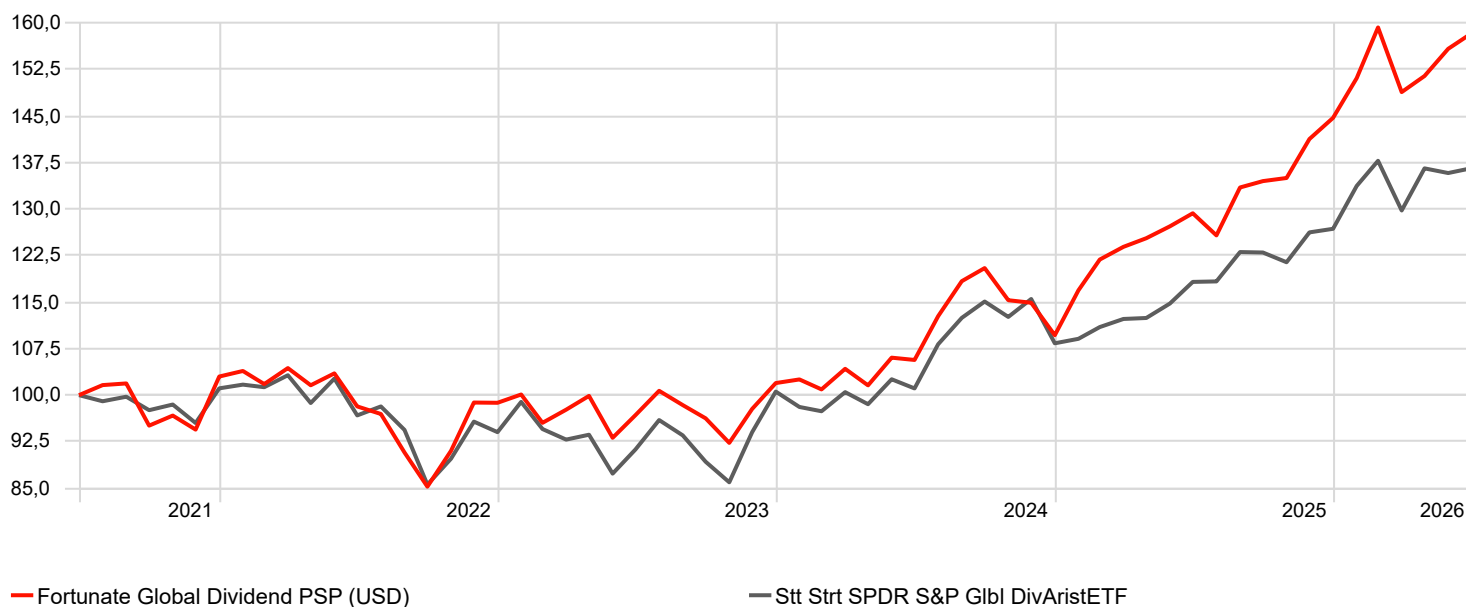

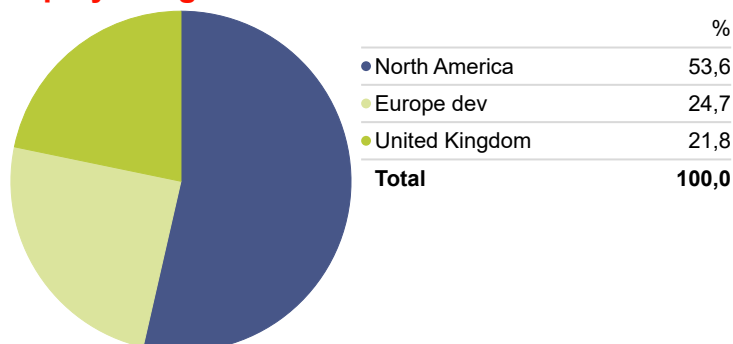

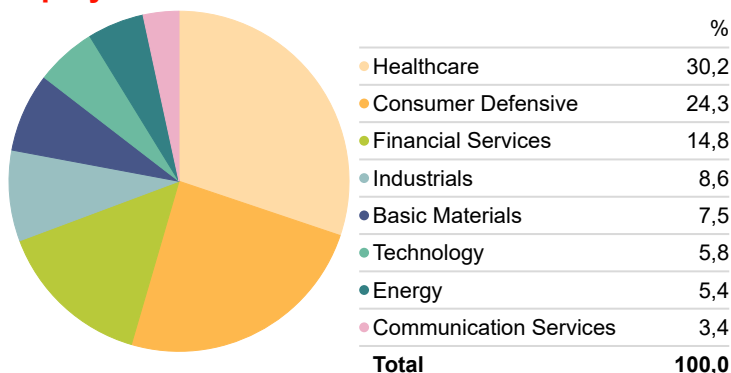
Investment Growth
