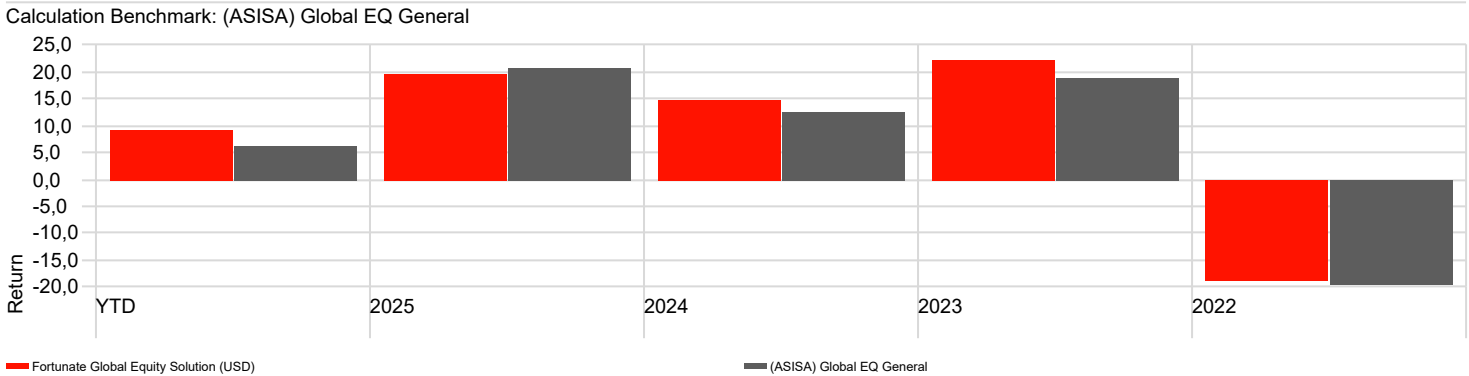

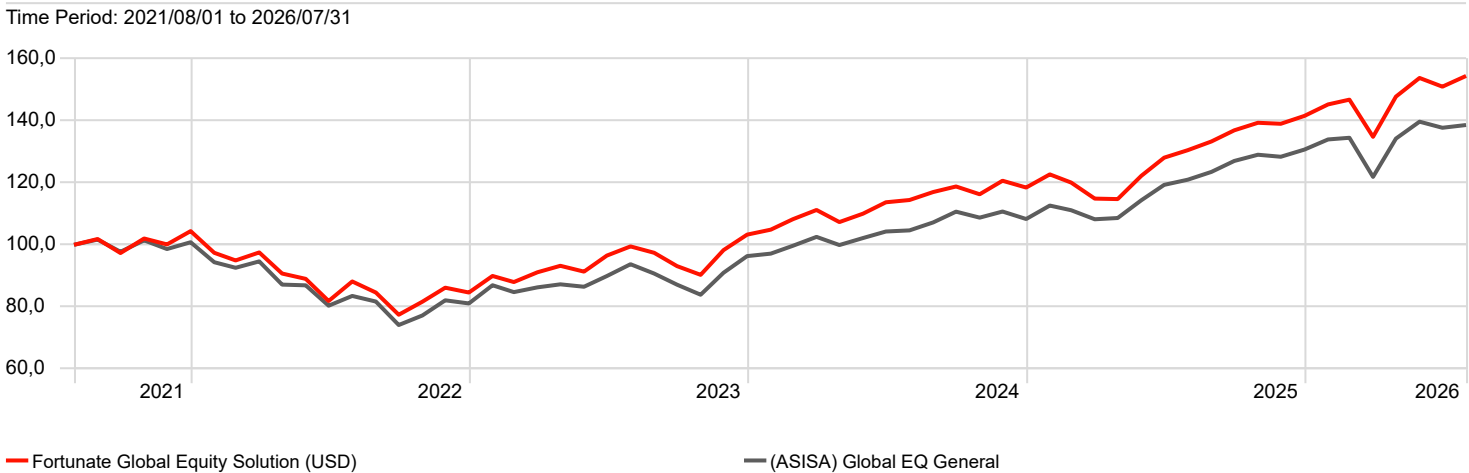

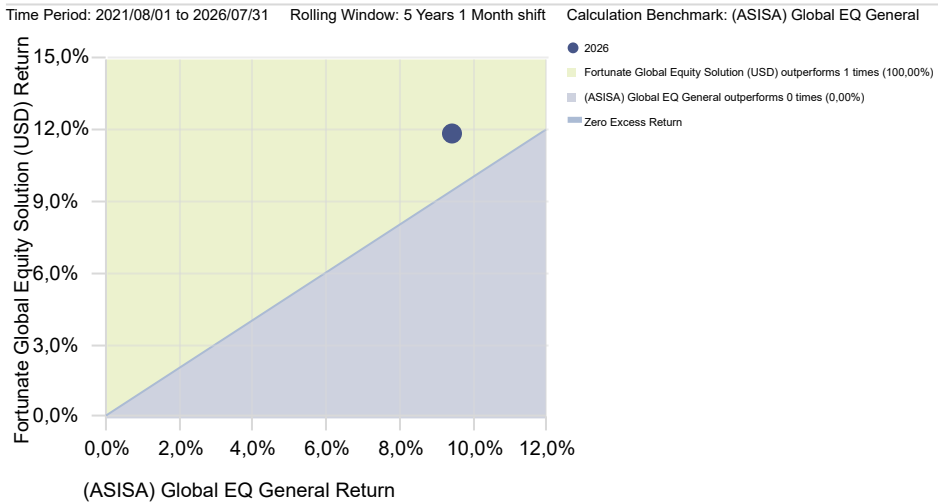
Investment Growth



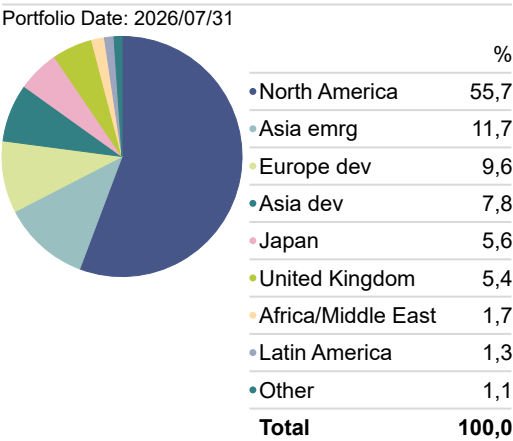

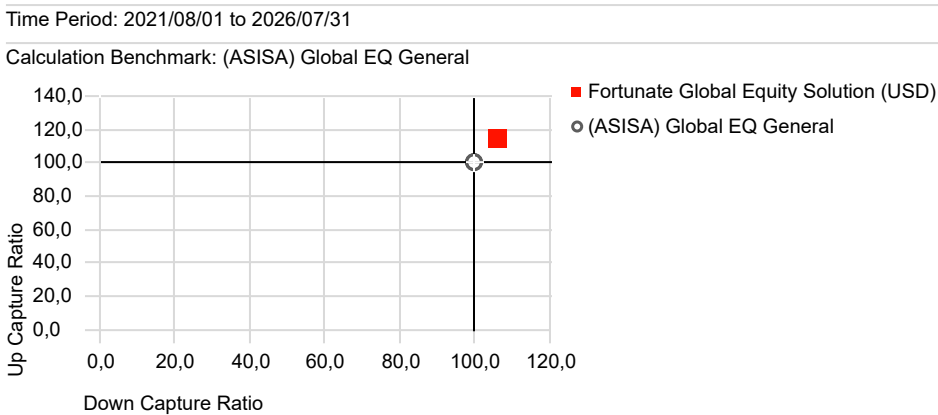
Over/Under Benchmark Performance
