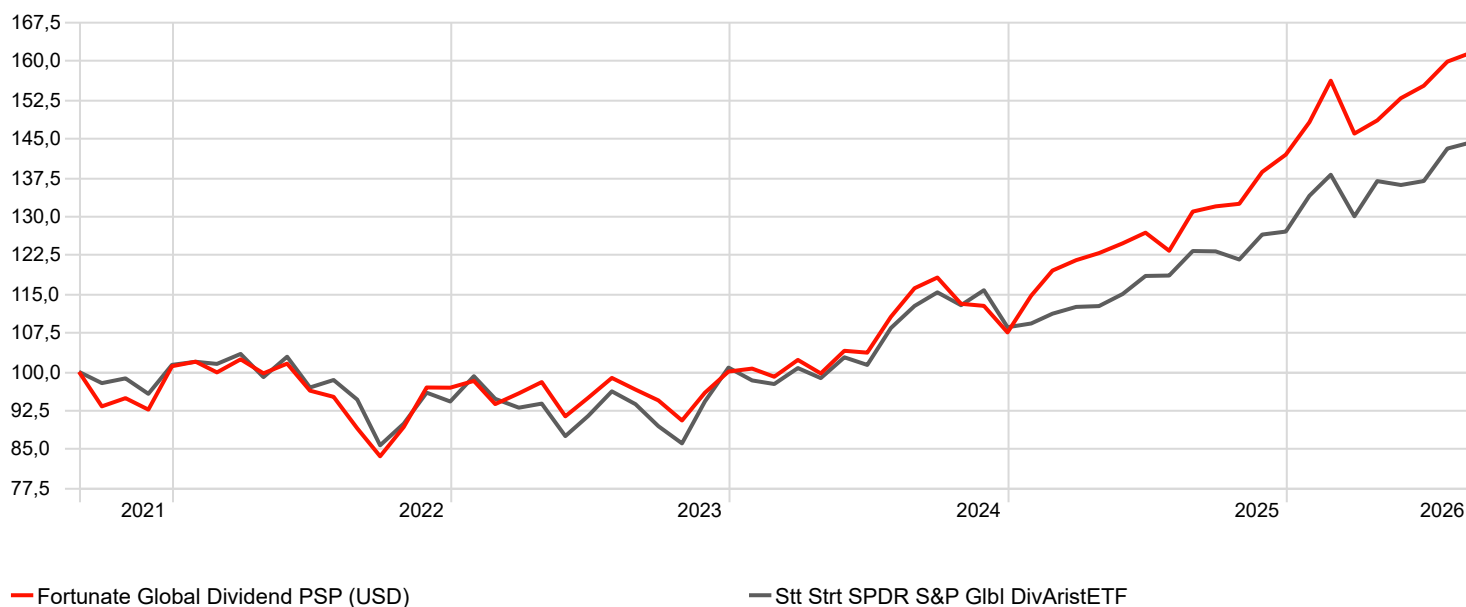

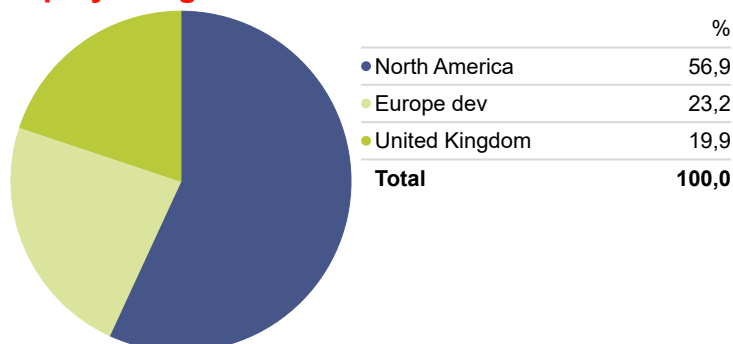

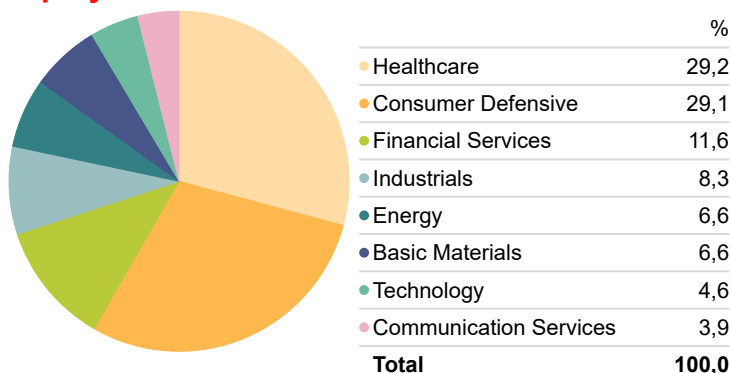
Investment Growth
